#### Number of workshops and categories of participants in 2017 and 2018.

Within the period from January till August of each year (2017 and 2018) WCO RTC Astana organized per 2 workshops :





4-5 April in Almaty city in cooperation with OSCE program office in Astana and GIZ - German society for international cooperation was held workshop on «Carnet ATA - features of practical application within the territory of the Eurasian Economic Union» with the involvement of experts from customs services of Russian Federation, Republic of Belarus and Republic of Kazakhstan, as well as from Chambers of Commerce of these countries. 6 experts and 70 trainees took part in the workshop (33 – SRC MF RK employees, 3 – customs officers and Chamber of Commerce of Kyrgyzstan, 34 – representatives of business of Kazakhstan).



With the support of OSCE Programme Office in Astana city organized an international workshop **"Free (special)** economic zones of foreign countries and member states of the Eurasian Economic Union" on August 28-29, 2018 in Aktau. 7 foreign customs representatives, 3 officers of SRC Headquarter, 22 territorial devisions of state revenue bodies, Business Association «Atameken» - 1, 5 representatives of FEZ managing companies, FEZ participants – 10, 47 participants were given certificates.



17-28 September was held World Customs Organization (WCO) Mission on the Risk Management System (RMS), consisting of three consecutive and interrelated workshops: 17-21September, "Risk Analysis and Profiling", September 24-26, "Risk Assessment and Selectivity" and 27 -28 September sub regional workshop "Trader Segmentation and Transit".

7 experts and 3 of them from China and Turkey and 57 participants took part at the workshop representatives of Uzbekistan, Tajikistan and Kyrgyzstan – 6, 51 officers of state revenue bodies of RK.

#### 5-8 November – workshop on WCO Strategic Trade Control Enforcement Programme

Internal network of SRC were equipped with **35 terminals of video conferencing**, and 2 in TMC.

Also in TMC there is installed modern technical equipment and software: **video conferencing system** «Polycom», training software «Simfox» (software-simulator on working with X-ray equipments by Rapiscan, Heimann), PRE-M (to select qualified officials to work with X-ray equipments), «TreFox» (basic software course on X-ray equipments), electronic check point and e-learning on Moodle platform in internal network.

Training-Methodical Center trainers are only qualified instructors in Kazakhstan and Central Asia who can conduct trainings on X-ray television installation operators. There is no a version of this software in Central Asia. TMC has full version of this software and in future we are planning expand the courses and go on new level i.e. plan to became the Center of Excellence in Central Asia on the mentioned specialization within WCO.






By Using indicated software since 2016 we conduct trainings for customs officials of check points on «Training on working with scanning equipment and image analyzing of x-ray equipment».

This training course enables to be skilled on: working with x-ray television installation; identifying geometrical images; overlay complexity; change of the angle view; difficulty connected with baggage variety. In this way, training operators, gained skills and experience are important and necessary to ensure

effective work in border security control.
